CCMR Targeted Professional Development Plan

*Due to COVID, the 20-21 percentages are a lot lower than normal. This is due to the seniors not being able to take the SAT or the TSI that year. The campuses were closed to testing and only allowing online proctored testing, so very few students were able to test. The 21-22 will also be skewed due to the pandemic. The main areas that will enhance these upward trends that are not already in place will be additional tracking of seniors to be sure that TSI, ACT, or SAT requirements are met. Also, there will be more emphasis given to Sophomores to get majority of these students tested with the TSI in the Spring so that they will be able to take Dual Credit classes in the Fall of their Junior year.
